OPEN JURIED SHOW: All artists (professional or non-professional) are invited to enter.

ACCEPTED WORK: Only original art completed within the past three years and never before shown in a Perkiomen Valley Art Center Open Juried Show will be accepted. Artist's original work, composition, and design only. No copies or likenesses of another artist's work including published source or reference work not attributable to the artist. No work aided by use of artificial intelligence. Works derived from paintings, reproductions, or photographs by other artists will not be accepted as well as crafts and/or artwork with objectionable subject matter. The show committee reserves the right to omit any submission that does not fit the show criteria. The show will be juried and judged in the categories specified. The decision of the judges is final. Artists will be notified of the status of their entries by e-mail.

CATEGORIES: Art will be juried and judged in the following categories:

- 1) Oils, acrylics and mixed media -- not under glass
- 2) Watercolors, acrylics, and mixed media -- under glass
- 3) Pastels -- under glass
- 4) Graphics -- drawings, prints, photographs
- 5) Sculpture

PLEASE PRE-REGISTER: Go to perkvalleyart.org to let us know you are entering your work and to help us expedite the show. Our volunteers thank you!

SIZE & SPECS: Maximum dimensions are 48 inches wide and 72 inches high, including frame. Larger than that will not be accepted for entry. All entries must be dry, wired and ready to hang. No sharp wires or edges. Improperly framed or damaged art will not be accepted.

SHOW ENTRY FEE & ENTRY FORMS: The entry fee allows each artist to submit two pieces of work: PVAC Members: \$25.00 Non-members: \$35.00. There will be no refund for art that is not accepted. A completed entry form must accompany your work. Block printing and adhesive name and address labels are welcomed! If your work is not for sale - print NFS in that space. Trim and attach the Artwork ID Label /Temporary Id Card to the back upper left corner of the work. The Artist receipt is retained by the artist. Go to perkvalleyart.org for additional forms.

SALES: A commission of 30% will be charged on all sales and benefits the mission of PVAC.

ART DROP-OFF & PICK-UP: PVAC will receive works on Thurs., Oct. 26, 3-6pm. If accepted, all work must remain in place for the duration of the show and must be removed on Dec. 16 - 11am - 2pm. Unaccepted work needs to be picked up on Nov. 5, 2-4pm. These are mandatory requirements. If you cannot pick up your work, please make arrangements for someone else to do it for you at the specified time and let us know.

AWARDS: Cash awards and prizes of more than \$1,800 are anticipated: Best of Show (\$200), and First (\$100), Second (\$50) and Third (\$25) Prizes in each category. Additional special awards may be given. All awards are given at the discretion of the judges and will be limited in categories with low participation. There must be at least five accepted entries in a category for 2nd and 3rd prizes to be awarded. All awards are presented with a certificate of merit signed by the judges and the PVAC president. Awards will be mailed to artists not present at the reception; they will not be handed out to a third party. Additional awards will be added as they are secured. If you know someone who would like to sponsor an award please contact PVAC.

JURORS OF SELECTION and AWARDS: Cindi Sathra: A lifelong resident of Bucks County, Pennsylvania; Cindi is an award winning, published photographer. Photographing nature and wildlife has always been her passion.

Her love of birds, animals and the outdoors are always an inspiration. Although, her love of the unusual has drawn her to start looking for some different subject matter as well - just to keep it interesting. Her photography has been on the cover of Pennsylvania magazine, used by National Wildlife Federation, Birds & Blooms magazine and the Cornell Lab of Ornithology.



Jas Szygiel (1956-) Jas is a life-long resident of Bucks County, Pennsylvania. He is graduate of Hussian School of Art and Arcadia University (BFA), For over thirty years Jas' work has been exhibited in Regional galleries and has participated in countless juried shows and competitions on the regional, national and international levels. Jas has taught at Hussian School of Art and as an adjunct professor at Arcadia University in the Fine Arts Department. He has won numerous awards for his paintings both in oil and watercolor. Jas' series of paintings, "The Bucks County Series" has led to paintings of Montgomery and Chester County, Hunterdon County, and Coastal New Jersey. Originals in watercolor and oil and limited edition prints are featured throughout the Bucks County area galleries. Jas' talents have been commissioned by private and corporate clients. Jas and his wife reside in Bucks County, Pennsylvania.
